- Onsite inspection fee (Per man day) Rs. 15000 will be charged for Animal Husbandry/Livestock, Apiary/Apiculture, Sea weeds/Aquatic Plants and Green house crop production.
- Certification fee Rs. 15000 for Animal Husbandry/Livestock and 20000 for Apiary/Apiculture, Sea weeds/Aquatic Plants and Green house crop production will be charged.
- If duplicate scope certificate or Transaction certificate is demanded extra fee @ 500 per certificate will be charged
- Additional inspection charges will be borne by Operator
- If operator transfer through NOC due to suspension/termination of its CB, the certification fee will be charged 50% in case where the existing certification has valid for more than six month.
- Verification inspection fee will be charged as per fee structure of respective category if applicable.
- Lodging/boarding/food expenses, actual cost will be borne by Operator
- All tax applicable will be extra.
